



## LIABILITY WAIVER

It is a REQUIREMENT to sign this form before participating in any of the Grandma Gatewood Legacy Hikes.

By signing this document, I acknowledge that I will be participating in outdoor activities that are potentially dangerous including but not limited to; walking, hiking, and backpacking organized by PRIME TIME FOR WOMEN, INC. The waiver of liability is an agreement that my participation in any of the Grandma Gatewood Legacy Hikes is strictly voluntary and of my own choice and that I agree 100% to accept personal responsibility for all and any foreseen and unforeseen events that may occur during, including to and from, the Hike.

I understand that during the Grandma Gatewood Legacy Hike, I may be exposed to a variety of hazards and risks, foreseen or unforeseen, which are inherent in outdoor excursions. These inherent risks include, but are not limited to, the dangers of serious personal injury, property damage, and death ("Injuries and Damages") from exposure to the hazards of outdoor activities and travel to and from these activities.

PRIME TIME FOR WOMEN, INC have not tried to contradict or minimize my understanding of these risks. I know that Injuries and Damages can occur by natural causes or activities of other persons, animals, trip members, trip organizers and third parties, either as a result of negligence or because of other reasons.

PRIME TIME FOR WOMEN, INC take no responsibility for me and will not be held responsible for any injuries or accidents that may occur during the Hike. Outdoor sports are inherently dangerous, and accidents will happen and that risks of such Injuries and Damages are a part of outdoors adventure events. I appreciate that I may have to exercise extra care for my own person and for others around me in the face of such hazards.

In consideration for my acceptance as a participant in the Grandma Gatewood Legacy Hike, I confirm my understanding that:

PRIME TIME FOR WOMEN, INC does not certify or confirm the qualifications of the founders as trained to provide first aid, CPR, or any rescue action. I further understand that on the Hike there may not be search, rescue, medical facilities or expertise necessary to deal with the Injuries and Damages to which I may be exposed.

The Hike officially begins and ends at the location designated by PRIME TIME FOR WOMEN, INC. The Hike does not include carpooling, transportation, or transit to and from the Hike, and that I am personally responsible for all risks associated with this travel.

If I decide to leave early and not to complete the Hike as planned, I assume all risks inherent in my decision to leave and waive all liability against PRIME TIME FOR WOMEN, INC arising from that decision. Likewise, if the HIKE has concluded and I decide to continue hiking on my own, I assume all risks inherent in my decision to go forward and waive all liability against PRIME TIME FOR WOMEN, INC arising from that decision.

Backpacking/hiking/rock climbing are physical activities involving a large amount of walking and physical exertion. By signing this waiver, I signify that I am in good general health, free from cardiovascular and respiratory disease, have good exercise tolerance and that my physician approves of my participation in such activities.

To the fullest extent allowed by law, I agree to WAIVE, DISCHARGE CLAIMS, AND RELEASE FROM LIABILITY PRIME TIME FOR WOMEN, INC, and their founders from any and all liability on account of, or in any way resulting from Injuries and Damages, even if caused by negligence of PRIME TIME FOR WOMEN, INC or their founders.

I further agree to HOLD HARMLESS PRIME TIME FOR WOMEN, INC and their founders from any claims, damages, injuries, or losses caused by my own negligence while a participant on the HIKE. I understand and intend that this assumption of risk and release is binding upon my heirs, executors, administrators and assigns.

This Agreement is intended to be as broad and inclusive as is permitted by law. If any provision or any part of any provision of this Agreement is held to be invalid or legally unenforceable for any reason, the remainder of this Agreement shall not be affected thereby and shall remain valid and fully enforceable.

By signing, I freely and voluntarily assume all risks of such Injuries and Damages.
